Section 2.1A Composition, Election and Terms of Members.

There shall be a Board of County Commissioners which shall consist of five members serving staggered terms of four years. One Commissioner residing in each district shall be elected by qualified voters in the district in which they reside ~~of the County~~.

2.8A Composition, Election, and Term of Members.

There shall be a Charter Review Board composed of ten (10) members, two (2) members from each commission district, who shall serve staggered terms of four (4) years without compensation, and who shall be elected by qualified voters in the district in which they reside ~~county wide by the voters of Sarasota County~~ at the General Election.
